Resolution Regarding Supplemental Department P&T Guidelines

Whereas, Southern Connecticut State University (SCSU) exists for the primary purpose of furthering academic excellence;

Whereas, The SCSU Faculty Senate is the official governing body for shared governance;

Whereas, The Faculty Senate recognizes that departments have distinct varieties of needs in the areas of Teaching Load, Creative Activity, Service, and Professional Attendance and Participation; and

Whereas, The Faculty Senate is responsible the procedures for Faculty Evaluations; now therefore, be it

Resolved, That the Departments **may choose** to create and publish Supplemental Department P&T Guidelines as supplementary document to the Faculty Senate's approved P&T Procedures document;

Resolved, The Supplemental P&T Department Guidelines <u>shall not</u> replace, either in full or in part, the P&T Procedures document;

Resolved, That the departments have a unanimous department vote, via secret ballot, of approval/support for their Supplemental Department P&T Guidelines;

Resolved, That the Supplemental Department P&T Guidelines shall be approved by the Dean of the School/College;

Resolved, That the Supplemental Department P&T Guidelines document is presented to the Faculty Senate and SCSU-AAUP for review and confirmation that contents of the Guidelines do not conflict with or contradict the Faculty Senate documents or the CBA;

Resolved, That the Faculty Senate's confirmation will be documented in the form of a vote of approval and shall not signify endorsement of the Guidelines;

Resolved, That each department adopting Supplemental Department P&T Guidelines shall implement them at the beginning of the first academic year beginning at least one year after the Faculty Senate approval date; and

Resolved, That the department DEC will communicate the Supplemental Department P&T Guidelines and its effective date to any candidate, upon the approval by the Faculty Senate of said Guidelines.
